I've been contacted by one LPN who asked if the LaRoche program was eligible for EISP and VANEPP support. I reviewed the program information that she supplied and since it can be completed in less than one year, is under the 90 credit limit, and the school is accredited, it appears that it could be supported through EISP and VANEPP. I forwarded it to Helen for her review.

However, employees wishing to apply for EISP and VANEPP for the LaRoche program need to be aware that EISP is capped at \$410 per credit. I checked the school's website and noted that undergrad credits at LaRoche are \$500 per credit, so it would be the employee's responsibility to pay the difference. I did not see a different pricing schedule for the RN classes. Also, EISP funding follows traditional academic semesters (Jan-April, May-August, Sept.-Dec. and the deadline to apply for May funding is 3-2-09 (next Monday). So although this sounds like a wonderful opportunity, we would not be able to offer scholarship support for the Summer 09 classes; we could offer it for the fall semester but employees need to be aware that they will have to pay \$90 per credit out of pocket, plus their books and fees.

We do have EDF money this year but it is about 70% depleted and we cannot guarantee funding to cover the April semester and tuition costs over the \$410 cap. Also we cannot guarantee EDF in FY10 to cover additional program costs next year.

If the RN program at LaRoche costs less than their undergrad program costs, funding will then not be an issue, but the April start date will be. When I responded to the employee who contacted me, I asked her how what the tuition costs are. I didn't respond to Ms. Beattie yet, and I don't know if Helen wants to, if this appears to be a program that our employees cannot afford to attend. If EISP covered the costs 100%, they still would not be able to do it until later this year, as well.
